RULES AND REGULATIONS:

1. Prizes are non-transferable: 12 monthly travel draws in total with a retail value of \$27,456.00.
2. Tickets are payable in full - \$100.00. Cash, e-transfer and credit card are acceptable forms of payment and paid to BGC Cochrane & Area (BGCCA). All payments must be received by the last day of ticket sales, prior to each draw date. Ticket sales will be ongoing up to February 28th, 2024, or until the allotted 500 tickets are sold, whichever comes first. Payment is required prior to being eligible for the 2023-24 draws. Tickets are non refundable.
3. All trips and travel vouchers must be booked through Julia Lutchman at Found Travel Management, Cochrane, AB within 180 days of the draw date. After the 180 day period, if the trip or travel voucher is not booked, then it reverts to \$850 cash prize.
4. All travel prizes, including those booked with the voucher must be used within one year of the booking date. All prizes are guaranteed for 365 days from the draw date. If a trip is not book within the 365 days of the draw date or subsequently, the cash payout is not claimed within the 365 days after the draw date, unclaimed prizes will be donated to the BGCCA and used as per our approved Use of Proceeds, upon AGLC approval.
5. Should there be a destination previously quoted not offered or has been cancelled at the time of claiming your prize, an alternative of the same value will be suggested.
6. If you do not want the trip or voucher awarded, you will be awarded \$850.00 cash payout.
7. If you or your designate choose not to take the trip as awarded, you may choose an alternate trip valued at equal value. Any amount over and above this figure shall be your responsibility.

8. All travel is non-transferable, the trip cannot be resold.
9. All prizes are tentative and are subject to change due to availability until time of booking. All packages are based on double occupancy unless otherwise noted.
10. All airfare is from quoted from Calgary. Winners are responsible for all travel costs to their chosen airport. Any additional resort charges, including but not limited to, resort or cleaning fees are not included and is the responsibility of the winner to pay.
11. Flexibility is required as hotels may have conventions and other black out dates inside holiday periods.
12. Winners are required to sign required travel waivers related to COVID-19, travel advisories, declined insurance and any other applicable agency waivers at the time of booking.
13. Mandated vaccine requirements and/or testing for exit and/ or entry into the visiting/ returning country of travel are solely the responsibility of the winner and their travelling companions.
14. Provide proof of valid out-of-country medical insurance if travelling out of country.
15. Upgrades may be added to any trip at the winner's expense.
16. No insurance whatsoever is included in the prizes. Insurance available for purchase will be quoted by Found Travel Management once the trip has been booked. The value of the trip cannot be insured even if an upgrade is done by the winner.
17. Raffle tickets shall not be sold to a person under the age of 18 or have a person under the age of 18 names written on the ballot.
18. There are no restrictions on the licensed charity members or their families buying tickets.
19. 550 tickets will be sold. All tickets sold and unsold, and all raffle associated paperwork are retained for 2 years from the draw date.
20. In the event there are 2 names listed on the winning ticket, BGCCA will award the prize to only the first individual identified on the ticket. BGCCA and AGLC are not responsible for any disputes which may arise between the different individuals whose names appear on the ticket stub. In case of disputed all decisions by BGCCA are final.
21. One ticket will be drawn on the first Tuesday of every month starting April 2023 and the final draw March 2024. The first ticket drawn is for the predetermined trip or voucher. All winning tickets are eligible for all 12 draws.
